# National Electricity Amendment (Minor changes 3) Rule 2021 No. 15

### 1 Title of Rule

This Rule is the *National Electricity Amendment (Minor changes 3) Rule 2021 No. 15.* 

#### 2 Commencement

This Rule commences operation on 10 January 2022.
