1 Title of Rule

This Rule is the *National Electricity Amendment (Minor changes 1) Rule 2022 No. 3*.

2 Commencement

This Rule commences operation on 21 April 2022.

3 Amendment to the National Electricity Rules

The National Electricity Rules are amended as set out in Schedule 1.
