



## **Draft National Gas Amendment (Minor changes 2) Rule 2024**

The Australian Energy Market Commission makes the following Rule under the National Gas Law to the extent applied by:

- (a) the *National Gas (South Australia) Act 2008* of South Australia;
- (b) the *National Gas (ACT) Act 2008* of the Australian Capital Territory;
- (c) the *National Gas (New South Wales) Act 2008* of New South Wales;
- (d) the *National Gas (Queensland) Act 2008* of Queensland;
- (e) the *National Gas (Tasmania) Act 2008* of Tasmania;
- (f) the *National Gas (Victoria) Act 2008* of Victoria;
- (g) the *National Gas (Northern Territory) Act 2008* of the Northern Territory;
- (h) the *National Gas Access (WA) Act 2009* of Western Australia; and
- (i) the *Australian Energy Market Act 2004* of the Commonwealth.

## **Draft National Gas Amendment (Minor changes 2) Rule 2024**

### **1 Title of Rule**

This Rule is the *Draft National Gas Amendment (Minor changes 2) Rule 2024*.

### **2 Commencement**

This Rule commences operation on 29 August 2024

### **3 Amendment to the National Gas Rules**

The National Gas Rules are amended as set out in Schedule 1.

## **Schedule 1      Amendment to the National Gas Rules**

(Clause 3)

### **[1] Rule 48                      Requirements for access arrangement (and access arrangement proposal)**

In the Note of rule 48(1)(e), omit "(See rule 103)", and substitute "(See rule 68D)".

### **[2] Rule 465                      Claims relating to administered market states**

In rule 465(1) omit "natural gas" and substitute "gas".

### **[3] Rule 703                      Defintions**

In rule 703, in the definition of gas demand, omit "gas" and substitute "covered gas".

### **[4] Rule 704                      Entitlement to compensate**

In rule 704, omit each occurrence of "natural gas service" and substitute "covered gas service".

### **[5] Rule 704                      Entitlement to compensate**

In rule 704(3), omit "using gas" and substitute "using covered gas".

### **[6] Rule 704                      Entitlement to compensate**

In rule 704(3), omit "that gas" and substitute "that covered gas"

### **[7] Rule 706                      No exacerbation of direction costs**

In rule 706(3), in the definition of exacerbated direction costs, omit "natural gas service" and substitute "covered gas service".

### **[8] Rule 707                      Determination and payment of compensation claims**

In rule 707(9)(b), omit "natural gas services" and substitute "covered gas services".

### **[9] Rule 707                      Determination and payment of compensation claims**

In rule 707(10)(c), omit "that sells gas, to include gas consumed", and substitute "that sells covered gas, to include covered gas consumed".

In Rule 707(11)(b)(iii), omit each occurrence of "natural gas", and substitute "covered gas".
