

# Draft National Gas Amendment (Dandenong Liquefied Natural Gas Storage Facility) Rule 2010

under the National Gas Law as applied by:

- (a) the National Gas (South Australia) Act 2008;
- (b) the National Gas (ACT) Act 2008 of the Australian Capital Territory;
- (c) the National Gas (New South Wales) Act 2000 of New South Wales;
- (d) the National Gas (Queensland) Act 2008 of Queensland;
- (e) the National Gas (Tasmania) Act 2008 of Tasmania;
- (f) the National Gas (Victoria) Act 2008 of Victoria; and
- (g) the National Gas (Northern Territory) Act 2008 of Northern Territory;
- (h) the Australian Energy Market Act 2004 of the Commonwealth.

# Draft National Gas Amendment (Dandenong Liquefied Natural Gas Storage Facility) Rule 2010

#### 1 Title of Rule

This Rule is the Draft National Gas Amendment (Dandenong Liquefied Natural Gas Storage Facility) Rule 2010.

#### 2 Commencement

This Rule commences operation on [COMMENCEMENT\_DATE].

## 3 Amendment of the National Gas Rules

The National Gas Rules are amended as set out in Schedule 1.

#### Schedule 1 Amendments of the National Gas Rules

(Clause 3)

### [1] Rule 200 Definitions

In Rule 200, omit the following definitions:

**available LNG capacity** means the amount of LNG storage capacity that a person holds at any time on a gas day less the amount of that person's LNG stock at that time.

**declared LNG storage provider** means a person designated as a declared LNG storage provider under legislation of the adoptive jurisdiction.

**declared LNG supplier** means a person designated as a declared LNG supplier under legislation of the adoptive jurisdiction.

**LNG storage transfer** means a transfer of LNG storage capacity or LNG stock in accordance with rule 282.

#### [2] Rule 200 Definitions

In Rule 200, insert the following definition in alphabetical order:

**LNG Storage Provider** means a Storage Provider for an LNG storage facility.

#### [3] Rule 200 Definitions

In Rule 200, substitute the following definitions:

**LNG storage capacity** means rights to hold capacity in an LNG storage facility granted by an LNG Storage Provider to a Market Participant, AEMO or any other person.

LNG storage facility means a storage facility for the storage of LNG.

**scheduling instruction** means an instruction given by AEMO to a Market Participant, or, in the case of an LNG injection bid, to an LNG Storage Provider, pursuant to rule 215

#### [4] Rule 200 Definitions

In Rule 200, move the definition of "scheduling" into alphabetical order.

#### [5] References to the LNG storage facility in various clauses

In the definitions of "LNG connection point", "LNG injection bid", "LNG stock", "storage facility", "storage space" and rule 279(2), omit "the LNG storage facility" wherever occurring and substitute "an LNG storage facility".

### [6] Rule 278 Obligations of AEMO

In rule 278, omit "and managing the LNG reserve".

## [7] Rule 279 Obligations of the LNG storage provider

Omit the heading and substitute "Obligations of an LNG Storage Provider".

### [8] Rule 279 Obligations of the LNG storage provider

Omit rule 279(1) and substitute:

(1) An LNG Storage Provider must ensure that an LNG storage facility is utilised with the objective of maintaining LNG stock at the highest level possible.

#### [9] Rule 279 Obligations of the LNG storage provider

Omit rule 279(3) and substitute "[Deleted]".

#### [10] Rule 279 Obligations of the LNG storage provider

After rule 279(3), insert:

- (4) An LNG Storage Provider must as soon as reasonably practicable after the end of each gas day provide AEMO with the following information in respect of an LNG storage facility:
  - (a) the total quantity of LNG stock at the end of the gas day; and
  - (b) the total quantity of LNG stock held on behalf of Market Participants at the end of that gas day which is available to be bid into the Market.

## [11] Rule 280 Declared LNG supply agreement

Omit rule 280 in its entirety, including the heading, and substitute:

## 280 Provision of information relating to an LNG storage facility

(1) An LNG Storage Provider must, subject to the terms and conditions of the declared LNG supply agreement (where relevant), keep AEMO informed in a timely manner of all matters or circumstances relating to the operation of an LNG storage facility that may affect the ability of AEMO to schedule LNG injection bids or use the LNG reserve.

## [12] Rule 281 LNG storage capacity

Omit subrules 281(1), 281(2), 281(3) and 281(4) and substitute "[Deleted]" in each case.

#### [13] Rule 281 LNG storage capacity

In rule 281(5), omit "and keep updated".

#### [14] Rule 281 LNG storage capacity

After rule 281(5), insert:

(6) An LNG Storage Provider must provide the register referred to in subrule(5) to AEMO as soon as reasonably practicable after the end of each gas day.

## [15] References to LNG Storage Provider in various clauses

In Rule 279(2) and 281(5), omit "The LNG storage provider" and insert "An LNG Storage Provider" wherever occurring.

## [16] Rule 282 Transfers of LNG storage capacity and LNG stock

Omit Rule 282 in its entirety, including the heading, and substitute "[Deleted]".

## [17] Rule 283 Liquefaction of gas

Omit Rule 283 in its entirety, including the heading, and substitute "[Deleted]".

# [18] Rule 284 Vaporisation of LNG and LNG injection bids

In Rule 284(2), omit "the LNG storage provider" and substitute "an LNG Storage Provider".

## [19] Rule 285 LNG reserve

Omit Rule 285 in its entirety, including the heading, and substitute "[Deleted]".

## [20] Rule 286 Provision of information

Omit Rule 286 in its entirety, including the heading, and substitute "[Deleted]".
