ERC0169 – Expanding competition in metering and related services



IMPORTANT NOTE

These tables provide a high-level summary of the reordering of provisions in Chapter 7 of the National Electricity Rules ("NER") by the Draft National Electricity Amendment (Expanding competition in metering and related services) Rule 2015 ("Draft Rule").

A reference in these tables to an 'Old Clause' is a reference to a rule or clause (as the case may be) of version 69 of the NER and a reference to a 'New Clause' is a reference to a draft rule or draft clause (as the case may be) in the revised Chapter 7 of the NER to be introduced under the Draft Rule (if made). These tables do not provide details of amendments to existing provisions in Chapter 7 of the NER by the Draft Rule.
