National Electricity Amendment (Second Minor Changes) Rule 2015 No. 11

1 Title of Rule

This Rule is the *National Electricity Amendment (Second Minor Changes) Rule 2015 No.11*.

2 Commencement

This Rule commences operation on 5 November 2015.

3 Amendment of the National Electricity Rules

The National Electricity Rules are amended as set out in Schedule 1.

4 Amendment of the National Electricity Rules

The National Electricity Rules are amended as set out in Schedule 2.

5 Savings and Transitional Amendments to the National Electricity Rules

The National Electricity Rules are amended as set out in Schedule 3.

Schedule 1 Amendment to the National Electricity Rules

(Clause 3)

[1] Clause 5.3A.2 Definitions and miscellaneous

In clause 5.3A.2(b), omit "*Connection Applicant*," and substitute "*Connection Applicant*."

[2] Clause 5.10.2 Definitions

Omit the definition of "**potential transmission project**" and substitute:

potential transmission project means investment in a transmission asset of a *Transmission Network Service Provider* which:

- (a) is an *augmentation*; and
- (b) has an estimated capital cost in excess of \$5 million (as varied in accordance with a cost threshold determination); and
- (c) the person who identifies the project considers is likely, if constructed, to relieve forecast constraints in respect of *national transmission flow paths* between *regional reference nodes*.

[3] Clause S5.2.5.11 Frequency Control

In clause S5.2.5.11(b)(2)(ii)(A), after "20% of its maximum operating level times the" insert "percentage".

Schedule 2 Amendment to the National Electricity Rules

(Clause 4)

[1] Chapter 10 Substituted Definitions

In Chapter 10, in the definition of "*NSCAS need*", omit clause (a) and substitute:

- (a) maintain *power system security* and reliability of *supply* of the *transmission network* in accordance with the *power system security standards* and the *reliability standard*; and

[1] Chapter 11 Savings and Transitional Rules

In Chapter 11, omit the heading "**ZZG Improving demand side participation information provided to AEMO by registered participants**" and substitute:

provided to AEMO by registered participants**
