## **National Gas Amendment (Minor Changes) Rule 2014 No. 4**

### **1 Title of Rule**

This Rule is the *National Gas Amendment (Minor Changes) Rule 2014 No. 4*.

### **2 Commencement**

This Rule commences operation on 1 July 2014.

### **3 Amendment of the National Gas Rules**
