## **National Gas Amendment (Minor Changes) Rule 2013**

### **1 Title of Rule**

This Rule is the *National Gas Amendment (Minor Changes) Rule 2013 No. 3*.

### **2 Commencement**

This Rule commences operation on 4 July 2013.

### **3 Amendment of the National Gas Rules**
