



National Electricity Amendment (Removal of unaccounted for energy from liable load in the Retailer Reliability Obligation) Rule 2021 No. 16

under the National Electricity Law to the extent applied by:

- (a) the National Electricity (South Australia) Act 1996 of South Australia;
- (b) the Electricity (National Scheme) Act 1997 of the Australian Capital Territory;
- (c) the Electricity - National Scheme (Queensland) Act 1997 of Queensland;
- (d) the Electricity - National Scheme (Tasmania) Act 1999 of Tasmania;
- (e) the National Electricity (New South Wales) Act 1997 of New South Wales;
- (f) the National Electricity (Victoria) Act 2005 of Victoria;
- (g) the National Electricity (Northern Territory) (National Uniform Legislation) Act 2015 of the Northern Territory; and
- (h) the Australian Energy Market Act 2004 of the Commonwealth.

National Electricity Amendment (Removal of unaccounted for energy from liable load in the Retailer Reliability Obligation) Rule 2021 No. 16

1 Title of Rule

This Rule is the *National Electricity Amendment (Removal of unaccounted for energy from liable load in the Retailer Reliability Obligation) Rule 2021 No. 16*.

2 Commencement

Schedule 1 of this Rule commences operation on 1 May 2022.

Schedule 2 of this Rule commences operation on 3 June 2024, immediately after the commencement of Schedule 3 of the *National Electricity Amendment (Integrating energy storage systems into the NEM) Rule 2021 No. 13*.

3 Amendment to the National Electricity Rules

The National Electricity Rules are amended as set out in Schedule 1.

4 Amendment to the National Electricity Rules

The National Electricity Rules are amended as set out in Schedule 2.

Schedule 1 Amendment to the National Electricity Rules

(Clause 3)

[1] Clause 4A.A.1 Definitions

In clause 4A.A.1, insert the following definition in alphabetical order:

adjusted metered energy means the adjusted metered energy determined in accordance with clause 4A.F.3(b)(2A).

[2] Clause 4A.F.3 Share of one-in-two year peak demand forecast

In clauses 4A.F.3(b)(1) and (2), before "the aggregate of", insert "determine".

[3] Clause 4A.F.3 Share of one-in-two year peak demand forecast

In clauses 4A.F.3(b)(1) and (2), omit all references to "*adjusted gross energy*" and substitute "adjusted metered energy".

[4] Clause 4A.F.3 Share of one-in-two year peak demand forecast

After clause 4A.F.3(b)(2) insert:

(2A) the adjusted metered energy for a *connection point* for a compliance TI is calculated as follows:

$$\text{AME} = \text{ME} \times \text{DLF}$$

where:

AME is the adjusted metered energy amount to be determined;

ME is the amount of electrical *energy*, expressed in MWh, flowing at the *connection point* in the *trading interval*, as recorded in the *metering data* in respect of that *connection point* and that *trading interval* (expressed as a positive value where the flow is towards the *transmission network connection point* to which the *connection point* is assigned and a negative value where the flow is in the other direction); and

DLF is the *distribution loss factor* applicable at that *connection point*;

[5] Clause 4A.F.3 Share of one-in-two year peak demand forecast

In clause 4A.F.3(b)(3), insert "adjust " before "the quantity in", and omit "is to be adjusted".

[6] Clause 4A.F.3 Share of one-in-two year peak demand forecast

In clause 4A.F.3(b)(4), insert "adjust " before "the quantities in", and omit "are to be adjusted".

[7] Clause 4A.F.3 Share of one-in-two year peak demand forecast

In clause 4A.F.3(b)(5), insert "multiply " before "the final quantity", and omit "is to be multiplied".

Schedule 2 Amendment to the National Electricity Rules

(Clause 4)

[1] Clause 4A.F.3 Share of one-in-two year peak demand forecast

In clause 4A.F.3(b)(1), before "the aggregate of", insert "determine".

[2] Clause 4A.F.3 Share of one-in-two year peak demand forecast

In clause 4A.F.3(b)(1), omit all references to "*adjusted gross energy*" and substitute "adjusted metered energy".
